NOTICE IS HEREBY GIVEN that the Board of Supervisors of the County of San Bernardino will hold a public hearing on <u>Tuesday</u>, <u>December 16, 2014 at 10:00 a.m.</u>, in the Chambers of the Board of Supervisors, 385 North Arrowhead Avenue, First Floor, San Bernardino, CA. The purpose of the hearing is to consider the proposed substantial amendments to the 2014-2015 Community Development Block Grant (CDBG) Action Plan for the County's 2010-2015 Consolidated Plan as it pertains to the CDBG program and to solicit citizen comments regarding the proposed plan amendments.

BACKGROUND:

Each year since 1975, the County of San Bernardino has qualified to receive federal housing and community development grant funds from the United States Department of Housing and Urban Development (HUD) in the form of CDBG funds. These funds are to develop viable communities by providing decent housing, suitable living environments and expanded economic opportunities, principally for low- and moderate-income persons. These actions will assist in meeting an element of the Countywide Vision for sustainable infrastructures and housing communities as adopted by the County Board of Supervisors and SANBAG on June 30th, 2011.

Items may be added or deleted from the Proposed Substantial Amendments at the Board of Supervisors hearing.

If you challenge any decision regarding the above proposal in court, you may be limited to raising only those issues you, or someone else raised at the Board meeting described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the Board hearing.

Due to time constraints and the number of persons wishing to give oral testimony, time restrictions may be placed on oral testimony at the Board hearing regarding this proposal. You may make your comments in writing to assure that you are able to express yourself adequately.
